Test Standard: BS EN 16805: 2015 Diving equipment - Diving mask - Requirements and test methods

Type of product: Diving mask

Number of samples tested: Four (4) pairs.

Notes:

(1) It is the applicant's responsibility to ensure that the materials of mask, including any anti-fogging compound specified by the manufacturer, that may come into contact with the wearer's skin shall not be known to be likely to cause irritation or any other adverse effects to health.

(2) CE marking is not specified in BS EN 16805 but per 89/686/EEC, Article 13, the marking shall be affixed to the swim mask so as to be visible, legible and indelible throughout the expected life of the product. The format of this CE marking was given in the Annex IV of the captioned directive.

However, the CE marking was not found on the swim mask.
